Bipartisan Infrastructure Law (BIL)

The main purpose of the BIL (Bipartisan Infrastructure Law) weatherization program is to make improvements to energy efficiency, health and safety, and comfort in income-eligible households. The intended outcome of these weatherization retrofits is ultimately to lower energy costs for eligible households, but also to make the dwelling a healthier and safer place to live. These services have lasting impacts that improve client living situations, but also the overall housing stock across communities in the three counties we currently serve.
